

First Fifty Cases – Pretrial Confidential Readiness Statement, and other orders.

In preparation for the trials numerous steps must be taken and will be dealt with confidentially by the court in specific scheduling and processing of the video trials which will begin December 4, 2003.

1. Case Management Questionnaire. Although dates have passed it is possible that some of the medical reports, paper discovery, independent medical exams (if any) have not been completed and exchanged. Complete and return this questionnaire to Susie Steinhauer, by fax or email, before October 21.
2. Voire Dire. The court will conduct the bulk of voire dire, allowing counsel brief opportunity to further inquire. Any party may request the court to make specific inquiry by providing written request delivered to Susie Steinhauer before October 21.
3. Video Testimony of All Witnesses, must be filed directly and personally with Mary Randles at the clerk's office, together with all exhibits by November 14, 2003. Along with the testimony each party must file a statement as to the order in which they want the final trial tape to present the witness testimony. The adverse party must file indexed objections to each witness tape by November 14. The court will thereafter rule on specifically referenced objections in anticipation of preparing and certifying the final trial tape. All objections in the tape not so specifically identified will be considered overruled.
4. Jury Interrogatories. Proposed jury interrogatories shall be submitted to the court by November 14, 2003. This may be done by identifying appropriate case numbers for which the request applies, or simply state "all cases."
5. Jury venire costs. Because of the unique circumstances of jury selection and multiple trials, and the consequent burden upon the resources of the Summit County Common Pleas Court, if counsel fail to advise the court of settlement or other disposition by October 21, 2003, costs associated with the jury venire and other additional costs will be assessed against the parties in the event of settlement or dismissal prior to trial.
6. Magistrate Role. The court will preside over all of the trials, and the Magistrates of the Court, by order of reference, will function on behalf of the court during appropriate portions of the trials, including voire dire, opening statements, and final argument.
7. Bailiffs. Specially appointed bailiffs will monitor the jury viewing of the trial tape(s).
